PUBLIC NOTICE

It is for the information of all "Registered Medical Practitioners" registered with Punjab Medical Council under Punjab Medical Registration Act, 1916 and amendment Act, 2010 as under:-

It is hereby informed that all the "Registered Medical Practitioners" registered with Punjab Medical Council must ensure mandatory reporting of HIV patients to furnish the information in the prescribed format to NACO as per the directions of Hon'ble Supreme Court of India. The format for the same is available at the website of NACO. The directions of Hon'ble Supreme Court of India order dated 01.10.2010 in C.W.P. No. 535/1998 are reproduced below for ready reference:-

"As far as private Doctors treating HIV patients are concerned, we hereby direct Medical Council of India (For short, the MCI), to implement our above directions within two weeks from the Reporting Format being put on the Website. The MCI, in turn will issue appropriate directions to the private Doctors, to furnish the requisite information in the ART Reporting Format to NACO....."

Note: Any violation of the above direction shall be considered as breach of direction of Hon'ble Supreme Court of India and leads legal action.

Subject:- Order of the Hon'ble Supreme Court in WP No. 535/1998 titled Sahara House Vs. UOI & Other connected petitions dated 01.10.2010.

Sir,

This is in continuation to our letter dated 10.10.2010 circulated to Registrars of all the State Medical Councils in pursuance to the Supreme Court order in WP No. 535/1998 titled Sahara House Vs. UOI & Other connected petitions dated 01.10.2010.

The Council office vide letter dated 10.10.2010 directed the State Council to circulate among all the private doctors who are treating HIV patients to furnish the information in the prescribed format to NACO.

Further, in this regard a meeting was convened at Ministry of Health & Family Welfare, New Delhi, on 16/08/2018 whereby it was noted that the reporting of HIV cases from the private doctor was initiated, carried out for few months but could not pick up as expected. In the said meeting the Council office was directed to reiterate the previous order.

The direction of the Hon'ble Supreme Court order dated 01.10.2010 are reproduced below:-

"As far as private Doctors treating HIV patients are concerned, we hereby direct Medical Council of India (for short, the MCI), to implement our above directions within two weeks from the Reporting Format being put on the Website. The MCI, in turn will issue appropriate directions to the private Doctors, to furnish the requisite information in the ART Reporting Format to NACO....."

In view of the above, directions are to be issued by you to the medical practioners registered with your Council to ensure that there is mandatory reporting of HIV patients from private doctors. Further any violation of the above direction shall be considered as breach of directions of Hon'ble Supreme Court. The format for the same is available at the website of NACO.

A compliance report on the same may kindly be sent to the office of the Councils.
