PUBLIC NOTICE

It is hereby, informed that the Punjab Medical Council deliberated upon various representations received from interns for provisional registration in Punjab State/ Chandigarh. As per Public Notice issued by National Medical Commission Notification 18.11.2021 circular dated 04.03.2022, letter dated 14.07.2022, Public Notice dated 28.07.2022 and 21.09.2022, letter dated 19.10.2022 and Public Notice dated 21.10.2022 following decisions have been taken in this regard by the Punjab Medical Council:-

For FMG students the following flow chart will be followed:

Online	Physical/ Online/ Not Done	Pass	2 Years Internship in Medical College only. However, students already doing internship in other institutions shall complete the remaining part of Internship in Medical College only. If any candidate has already done 1 year internship and issued Permanent Registration Certificate, it shall stand revoked and surrender the certificate to this office, as Candidate has to complete the remaining internship.

- All Foreign Medical Graduate (FMG) candidates who have already applied in Punjab Medical Council for provisional registration and candidates who are willing to do internship in Punjab State, the seats will be allotted to these candidates as per NMC regulations only in medical colleges/ institutions.
- Applications will be called from FMGs and the notice will be uploaded on the website of PMC. The candidates who applied already need to apply again.
- 3. Time period of 15 days to be given for submission of fresh application by Foreign Medical Graduate candidates in this regard. (i.e. 01.11.2022 to 15.11.2022).
- All documents will be submitted by candidates as per checklist of provisional registration for FMGs, along with requisite fee for provisional registration of FMGs.
- 5. In addition the following documents will also be required from Candidates:
 - i. Self-attested copy of Aadhar card.
 - Travel History as per original passport entries of candidate/ alongwith complete copy of passport.
 - iii. Preferences column of 13 choices in application form for Medical Colleges to be filled by each candidate.
 - iv. Affidavit stating that all the information provided by candidate is correct & true as per his/ her knowledge.
 - v. FMGE merit list/ Marks.

(A) For Punjab State Resident:

Residence proof of candidate as per Punjab Government Policy dated 06.06.1996,

i) Candidates who have studied for a period of 5 year in Punjab or have studied in

Punjab for 2 years just preceding the qualifying examination for the admission.

ii) Children/ wards of

 The employees of Punjab Govt. posted in or outside Punjab State or working on deputation having at least 3 years of service.

b) The employee of Govt. of India posted in Chandigarh or in Punjab in connection with the affairs of the Punjab Govt. for a period of 3 years.

c) The employees of State Govt. institutions/undertakings who are posted in Chandigarh or in Punjab in connection with the affairs of the Punjab Govt. for a period of 3 years.

d) The employees having atleast 3 years of service in autonomous bodies/companies in which Punjab Govt. has 20% or more shares.

- e) The Residents who are residing outside Punjab on Account of their service either with the GOI or with the employees of the Govt. of Punjab in the matter of issue of Residence Certificate provided the permanent address of such employees fall in the reorganized Punjab i.e. on or after 01.11.66, as per their service books.
- f) The employees borne on the establishment of Punjab and the Haryana High Court discharging duties in connection with the affairs of the State of Punjab having atleast three years of service who have not availed this facility from their parent State and State of Haryana and U.T. Chandigarh

iii) Children/wards of the pensioners of Punjab Government irrespective of the fact that the original home of the retiree is in a state other than Punjab or he has settled

after retirement in or outside Punjab.

iv) Children/wards of persons who have settled in Punjab or had resided in Punjab for a period of atleast 5 years at any time prior to the date of submission of the application either in pursuit of a profession or holding of a job.

v) Children/Wards of persons who have held immovable property in Punjab for a period of 5 years, the property should be in the name of the parents/ guardians or

the candidate himself.

vi) Persons who were born in Punjab and produced a certificate to that effect.

Certificate from the competent authorities have to be issued for the same. However, preference is given to the category mentioned above.

(B) For Chandigarh resident:

(i) Candidates who had completed 10th, 10+1 and 10+2 from schools/colleges recognized by the Chandigarh Administration and situated in the Union Territory of Chandigarh, as regular student of the said school/college.

(ii) Candidates whose parents are residents of Chandigarh for the past 05 years immediately preceding the date of application even if they do not satisfy the criteria as laid down in condition No. 1 above, The requisite residence certificate issued from the office of Deputy Commissioner will be taken as proof for this purpose.

(iii) Candidates whose parents are employees of Central Government/State Government who are on deputation to U.T., Administration, including government employees of Chandigarh Administration / employees working in autonomous bodies/ companies in which Chandigarh Administration has 20% or more share, for the past 03 years immediately preceding the date of application even if they do not satisfy the criteria as laid down in condition No. 1 & 2 above.

Certificate from the competent authorities have to be issued for the same. However, preference is given to the category mentioned above.

Note: These conditions (i-iii) are waived off in respect of wards of serving defense personnel/ ex-servicemen vide letter No. 19/1/3-IH(3)-2007/18322 dated 14.09.2007.

- 6. Punjab Medical Council office-will scrutinize all the applications and prepare a tentative Merit list (as per result/score of Screening Test result) considering NMC Guidelines for all applicants.
- 7. Two (2) Merit list will be prepared for Punjab/ Chandigarh as per following criteria:-

 Candidates who are already completed or doing internship requiring extension in Punjab/ Chandigarh.

Candidates who are residents of Punjab State as per Punjab Government Policy dated 06.06.1996/ Chandigarh.

Candidates who are not covered under 1996 Personnel Policy as Punjab residents/ Chandigarh.

In case of more than one candidate have same NBE score, merit order will be determined on basis of the following criteria:-

- Candidate who has secured higher percentage of PCB theory marks in 10+2 examination.
- b. Candidate who has secured higher percentage of Biology theory marks in 10+2 examination.
- c. Candidate who is older.
- 8. Merit list will be displayed alongwith allotment list and the selected candidates will have to join the internship programme immediately but not later than 07 days from the date of result uploaded on official website of PMC.
- 9. Provisional registration will be issued to successful candidates who will join internship in due course of time at given medical college/institution.
- 10. If candidate does not join for internship at allotted medical college/institution within 7 days, the seat will be considered vacant and no extension will be granted for joining to candidate.
- 11. The unsuccessful candidates as declared by Punjab Medical Council will get fees refunded.
- 12. The internship fee charges and stipend payable will be solely at the discretion of the concerned state authorities.

Hence in view of this, the provisional registration will be issued to Foreign Medical Graduates, conditionally subject to verification of primary qualification (i.e. M.D.(Physician)/ M.B.B.S.) from concerned embassy and 10+2 from concerned board.
